- for Court of Justice, an order from an Assistant Chief Justice or the Chief Justice or their delegate;
  - for King's Bench, an order of an Associate Chief Justice or the Chief Justice or their delegate.
2. **I understand and agree that use of the digital recording is subject to the following terms and conditions:**
- a) I will not publish, broadcast, reproduce or otherwise disseminate the digital recording, including any annotation in the audio file, in any way.
  - b) I will not copy, save, upload or download the digital recording.
  - c) I will not authorize, assist or permit anyone to publish, broadcast, reproduce or otherwise disseminate the digital recording, including any annotation in the digital recording, in any way.
  - d) I will not provide the digital recording or copies of it, in any format, to any third party.
  - e) If there is a witness exclusion order in the proceeding, I will not disclose the contents of the digital recording to any prospective witness who has not given evidence.
  - f) When the digital recording is not being used for the purpose permitted by the undertaking, I will keep the digital recording in a secure place where it cannot be accessed by other persons.
  - g) I will destroy the digital recording and render it inoperable when the purpose for which the digital recording was provided to me has concluded.
3. **I understand and acknowledge that if I fail to comply with my undertaking, I may be liable for punishment for civil contempt of court.**
