



# FASD Probation

**1. Stay out of trouble**

I will stay out of trouble.

**2. Come to court**

I will come to court when I am told to.

**3. Notify of any change living/work/school/number**

I will tell either the court or \_\_\_\_\_ (insert name of probation officer) if I change the place where I am living or where I work or where I go to school. The telephone number of (insert name of probation officer) is \_\_\_\_\_.

**4. Location of Court**

The court is in Red Deer at 4909 48 Ave and the telephone number is 403-340-5250.

**5. Report change live/work/school**

I will tell my probation officer right away if I change where I live, where I work, or where I go to school.

**6. Report**

I will report to the probation office today; \_\_\_\_\_ (give location and/or phone number). I will see my probation officer again when they tell me to.

**7. Reside**

I will live at the place my probation officer tells me to live. I cannot live anywhere else unless my probation officer says it is ok and gives me a letter saying it is ok.

**8. Curfew**

I will be in the place where I live every day from \_\_\_\_\_ PM to \_\_\_\_\_ AM and I will not leave it during that time.

**A. May be out later with permission**

My probation officer may let me stay out later than \_\_\_\_\_ PM or leave the house before \_\_\_\_\_ AM but he/she will give me a letter of permission first and I will keep that letter with me when I go out of my house.

**B. stay in at night**

I will stay in the place where I live from \_\_\_\_\_ at night to \_\_\_\_\_ in the morning.

**9. No go sell alcohol**

I will not go to any places that sell alcohol. I can go to a restaurant to eat but cannot drink any alcohol while I am there.

**A. No go sell alcohol/not accept alcohol or drugs**

I will not go to any places that sell alcohol. I will not go to a liquor store and I will not accept alcohol or street drugs from anyone.

**10. ABSTENTION**

I will not use anything that can make me high or drunk. This includes things like:

**A. Alcohol**

Alcohol

**B. Street drugs**

Street drugs

Marijuana

Cocaine

Fentanyl

Ecstasy

Meth

Any other illegal street drug

Medical drugs not given to me by a doctor

It also includes more drugs than what my doctor told me to take

\*These are examples only

I will give a police officer a sample of my breath or urine if he/she asks for it.

**11. Weapons Restrictions**

I will not carry anything on me that is meant to be used as a weapon. This includes things like knives, clubs, guns, or anything else that can be used as a weapon.

**A. permission**

I can have these things only with permission from my probation officer.

**12. Not buy or own anything used to light a fire**

I cannot buy or own anything that can be used to light a fire, like matches or a lighter. I cannot buy or own anything that is an explosive substance or device.

**13. No Contact**

I will not contact \_\_\_\_\_ (insert name). That means I will not call, write to, e-mail, text, or use Skype, Tweet, Facebook, or any other way of sending him/her a message. That also means I will not get someone else to take the message for me.

**14. No contact as directed**

I also will not contact any other person that my probation officer \_\_\_\_\_ (insert name) tells me in writing not to contact, or \_\_\_\_\_ (please insert some wording as above)

**15. No contact list**

My probation officer may give me a list of people I cannot hang around with or talk to. I have to stay away from them. I will not get anyone to go see them for me.

**16. No Go**

I will stay 100 metres away from this place: \_\_\_\_\_. I can go to this place just once to get my things, but ONLY with the police.

**17. not be in/on motor vehicle**

I cannot be in or on any motor vehicle, like a car truck or motorcycle:

**A. Registered owner**

unless the registered owner of the motor vehicle is there.

**B. Written permission**

unless I have the written permission from the registered owner to be there.

**C. Passenger**

Unless I am a passenger in a bus or taxi.

**18. Travel**

I will not go out of Alberta unless I get a letter from my probation officer stating I have permission to leave Alberta.

**19. Restitution**
